MORE EVIDENCE MHUD ARE MANUFACTURING THE STATISTICS FOR ROTORUA

Today - Prime Minister Christopher Luxon announced a 32% reduction (or 1000 less children) being housed in emergency housing motels, since being elected on 14th October 2023.

However, according to Ministry of Housing, Urban & Development (MHUD)'s temporary housing dashboard for Rotorua, there were 294 children being housed in emergency housing motels in Rotorua as at 31st October 2023. As at 30th June 2024, this had increased by 12 children to 306.

So why is Rotorua bucking the national trend?

A 32% reduction from 294 would be 94 less children, resulting in 200 remaining in emergency housing, rather than an increase to 306.

Is there something amiss with MHUD's figures as suspected?

Or are MSD still importing homeless people into Rotorua emergency motels?

MHUD - Please explain.
