That all 7 Motels be returned to their original purpose.

I strongly oppose ALL 7 Motels having an extension granted for contracted emergency housing in relation to MHUD blatantly and arrogantly ignoring the decision handed down by the original commissioners hearing held in 2022. That was a hugely expensive exercise at the personal cost of residents, ratepayers, and taxpayer funds.

Contracted Emergency Housing has already taken an emotional, physical, and financial toll on the City of Rotorua and the Community of Rotorua who cared enough to oppose the previous consents.

A process was undertaken. A decision and instructions were put in place. Those parties involved in the consent process should be made to abide by that process. If not this is no longer a democracy for citizens but a pure mockery and undermining of a system created to deliver a fair and just outcome.

I strongly oppose ALL 7 Motels having an extension granted in relation to the flagrant violation by MHUD to ignore the resolution by the previous Commissioners to put in place an "Exit Plan" by June 2024 for the CEH to cease by December 2024.

This inaction confirms MHUD had "ABSOLUTELY NO INTENTION" of following the instructions of that hearing, and the Rotorua Lakes Council have taken NO ACTION to enforce that decision.

Therefore, to trust another extension process of 1 year would be irresponsible of those communities in this city who opposed the initial consent applications.

Lastly and most importantly: I strongly oppose all 7 Motels been consented for an extension and specifically the

In relation to the sale of our House in June 2024, the "application for an extension of CEH" lodged with the RLC in June 2024 was indicated in a letter from our Lawyer been the main reason for the Cancellation of the Sale Agreement by the Purchaser less that 24 hours of the agreement becoming unconditional.

For nearly 5 years this unorthodox practice of continuing to accommodate households/individuals in Motel/Hotel facilities (noted in the names of the locations above "motel" "hotel") has taken a huge personal toll on our family, physically, emotionally, mentally and now at a huge financial loss.

If the practice of importing households and individuals from other regions into our city was ceased immediately, then CEH would no longer be required and the supply and demand chain creating an industry for providers such as WERA, VISIONS OF HELPING HANDS, EMERGE and Te Pokapu would no longer be required to level it now exists.
