My submission is:

I oppose this resource consent application because:

- I have deep-rooted family connections in Waikite Valley, whereby my grandfather
 was one of the founding fathers of Waikite Valley as a settler after the second
 world war, and my father, colloquially known as 'The Mayor of Waikite', was
 active within this community for over 60 years. My mother still resides in the
 Valley and has called Waikite Valley home for over 50 years. I know the Valley
 well.
- I would like it recorded that my submission considers the principles of Tikanga Màori, emphasising the cultural, spiritual and community values that should guide decision making within each zone of the Rotorua District.
- I believe the location is inappropriate for this facility for several reasons, including inconsistency with the Rotorua District Plan, potential adverse effects on the surrounding community and wider community, and that Puaiti Road is an unsuitable location for such an activity.
- The Rotorua District Plan outlines clear zoning rules and objectives designed to maintain the character, amenity and mauri (life force) of residential and rural environments, as well as defining the natural character of areas within the District. This is exemplified in policy RUZ-P11 of the Rotorua District Plan, which

Document Set ID: 21300549 Version: 1, Version Date: 20/06/2025 states land use change should not create adverse effects on rural character and amenity values. I personally know that the Waikite Valley Community is one of the most close-knit, peaceful and balanced (rangimàrie and màtauranga taiao) supportive communities to be found within the wider Rotorua District, and I firmly believe facilities of this nature do not align with the objectives and polices put in place to preserve this rural zone and the rural activities that operate within it. Simply put, this is because the area is preserved as rural, for rural land use, not for residential rehabilitation facilities.

- Introducing the activity would set a concerning precedent in this location, community and zone. Essentially, this activity would wipe out the zoning protections established to preserve the intended use of land within this zone, as well as the landscape the community works hard to preserve. This would eliminate the importance of wahi noho (living spaces) being suitable for rural activities. I believe that the urban environment better aligns with the kaupapa and purpose of the proposed activity.
- With reference to issue RURZ-13: Character and Amenity Values of the Rotorua District Plan. The importance of maintaining character and amenity within the local Puaiti Road and wider Waikite Valley environment is a concept worth fighting for. I believe there are not many people within the Rotorua District who can, hand on heart, say they are fortunate to live in a community that holds community values steadfast in their beliefs that constitute the togetherness that is experienced in the Waikite Valley community. The activity described in this resource consent application is likely to introduce adverse effects which cannot be mitigated to the extent required to preserve the character and amenity of the road and Valley, such as safety risks, security concerns, emergency access, loss of utilities for example frequent power outages, increased traffic and distance from urban connections.
- With reference to issue RURZ-12: Maintenance of Productive Rural Land of the Rotorua District Plan. The productive rural land within Puaiti Road and the wider Waikite Valley District is vitally important to the economic future of Rotorua. Unsustainable land use practices, such as non-complying activities in this zone, have the potential to irreparably alter the landform and productivity of the immediate area. The whenua within this area is seen as taonga tuku iho, a treasured legacy, and its use should enhance its rural mana and mauri, which non-rural developments will not achieve in the community.
- With respect to traffic and safety concerns, Puaiti Road is a narrow rural road with limited capacity for increased traffic. Neighbouring Te Kopia Road is also very rural, with high farming traffic. This area is not designed for increased traffic, nor is safe for increased urban-like vehicle movements alongside the rural nature of the roading infrastructure. For example, and increase of 'day-to-day'/'shift work' like traffic to and from the facility, during peak winter weather when the Valley is blanketed in thick fog and farming machinery are on the roads,

The isolated nature of the site also poses significant safety concerns which cannot be mitigated, such as the distance from urbanised support for example there will be no safety net available when support is needed as the nearest urban support is a great distance away during times of potential unrest, emergency, or requirements for higher support that what is immediately available.

- With respect to security risks, while facilities of this nature do play an important role within a well-networked and easily accessible location in Aotearoa, the presence of such an activity within a small close-knit rural community is likely to generate safety, wellbeing and security concerns. Tikanga Màori advocates for activities that align with the principles of kotahitanga and unity, and whanaungatanga and relationships. I believe this facility will create division and tension in the local community, which conflicts with these values. Additionally, I do not believe that the operator has a well enough established track record of compliance with the District Plan rules, exemplified by their interactions with enforcement under the RMA earlier this year, which leads me to believe the operator is likely to inflict additional security risks on the community simply because they have previously demonstrated they do not intend to abide by the rules.
- With respect to inadequate infrastructure, and as mentioned above, the site is inappropriately equipped to provide for the successful and stable establishment of a facility where the occupants have a history of instability. Developing this facility of this scale in this location creates risks to local infrastructure and is likely to cause increased pressure on the community by way of emergency access and lack of other local facilities such as places for visitors to stop. Additional infrastructure such as water supply, sewage, electricity and stormwater disposal is lacking, and although proposed to be mitigated through the proposal, I believe should not be introduced causing alterations to the natural, rural landform.
- With respect to environmental impact, the rural character of Puaiti Road and Waikite Valley includes significant amenity and natural features, and biodiversity. The inclusion of this non-complying activity within this zone of this scale risks damaging these community assets, which is contrary to the goals of sustainable management outlined in the Rotorua District Plan.

I respectfully urge the Rotorua Lakes Council to decline this application and recommend that alternative, more appropriate sites be explored for the establishment of this facility in areas where access to support and family services are more readily available which will promote the success of this programme's intention.
