This facility doesn't fit our community needs or aspirations. Our remoteness to low traffic numbers enables us to enjoy using our roads, either walking, running or cycling.

Our family chose to live rurally for it's security, reduced population, community nature & serenity. Living in a Rural Zone means we don't have to worry about personal or property security or where our child plays. We know our neighbours and our community intimately & enjoy living within a close knit community.

We urge you to choose a more appropriate location for this type of service.
