I am a resident of Waikite Valley and I strongly oppose the establishment of a live-in residential support facility for parole participants at 473 Puaiti Road. My concerns include the following:

Inappropriate rural setting

This type of facility is not suited to the character of Waikite Valley. Our area is a quiet rural community made up of family homes, farms, and long-standing residents who value privacy, connection, and peace.

Proximity to school and daycare

The site is near a primary school and kindergarten. This raises safety concerns for children, staff, and families, and it's likely the local community—not the facility—would be left to manage increased security needs.

Impact on residents and traffic flow

A large portion of traffic—staff, participants, service providers, and weekend visitors—will pass directly by, or within close proximity to, my property. There are multiple access routes from Rotorua, but all channel vehicles through quiet rural roads and residential areas. This increase in traffic affects safety, privacy, and the sense of security we currently enjoy.

Isolation from essential services

The proposed location is approximately 40 minutes from Rotorua, with limited cell coverage and poor access to emergency services. This isolation is unsuitable for a facility intended to support high-needs reintegration.

Negative perception and property impact

The presence of a parole-based facility may shift public perception of Waikite Valley and introduce social stigma. This could affect community cohesion and have a long-term impact on property values and the area's appeal.
