Kia ora

Ko Wayne McEntee tōku ingoa, and I have lived in, and been connected by family and friends to the Waikite Valley for over 20 years. I love the area because it is a quiet, friendly community centered around the farming sector. Waikite Valley's beauty is in its isolation and natural taiao created by the low population, lack of development, and the rural activities it supports. The rural character of Waikite Valley is protected within the Rotorua Lakes Council District Plan, and I oppose the intensive development proposed due to the adverse effects on this rural landscape and community.

The proposed intensification of the site and its activities directly conflict with the landscape, and the district plan. I have concerns regarding the earthworks and sediment control and the impact these will have on surrounding properties, aswell as the increased traffic from visitation in weekends, or during weekdays when approved. The typically quiet roading network will be significantly impacted. Whānau is central to tikanga approaches, and I believe that the anticipated visitation numbers for both whānau and support services have been underestimated by the applicant.

I am also concerned about the precedent that an approval will set. Waikite Valley is isolated, with limited access to healthcare professionals, supports, training, emergency services, and it has unreliable infrastrucutre such as power and phone connectivity. This poses significant safety and security effects for the community when assistance is needed. The precedent of approving this application will cumulatively strain the support and emergency services within the rural zone.

I urge council to listen to the genuine concerns of the community and decline this application.
