4. UPDATE ON PROPOSED THERMAL MOTOR CAMP DEVELOPMENTS

Ken Kennedy introduced Kathryn Bloor (Facilities Manager for Waiariki Institute of Technology), who spoke to a PowerPoint presentation titled 'Development of Rotorua Thermal Holiday Park' (Attachment 1).

Kathryn Bloor then introduced Claire Ngati, the Institute's new Park Property Manager. She also spoke to the presentation and provided an update on the Institute's progress so far, explaining what their main objectives are for the proposed new development of this land.

Stuart Harris raised the point that the Committee had already been informed of Waiariki's objectives for the development of this land. He also commented that it had been agreed at the last meeting that members would be given the opportunity to peruse the lease prior to today's extraordinary meeting, but this had not occurred.

Murray Patchell stated that he had discussed with Alec Wilson, Kathryn Bloor and Jackie Pittman the need for Ngati Whakaue to be more informed, but had only received further information a week prior to this meeting. He had also requested a copy of the lease. This prevented Ngati Whakaue from having an opportunity to discuss with Council any issues regarding the land and the lease itself.

After further discussion it was agreed that Committee members were all in favour of the proposed development with the exception of the land marked as "Community House Construction Area" (coloured grey on Attachment 1 page entitled "Plan of Redevelopment"), which is proposed to be used for a building site for the trade training students and would conflict with Ngati Whakaue's plans.

SOUTHERN GOVERNMENT GARDENS CONNECTIVITY PLAN

Mark Spijkerbosch spoke to a Powerpoint presentation (Attachment 2) and overviewed the report, supported in part by Rebecca Cray. He explained that the aim of this project was to increase activity levels in the Southern Government Gardens by establishing "view-shafts and pathways" through this area, and improving connectivity between several locations in the Southern Government Gardens, in particular with the Rotorua Arts Village. The goal was to use local artists to create sculptures/carvings which would be placed along these "pathways" (on a rotational basis). Incorporated in the plan is the area surrounding the casting pool (Sulphur Lake) and an explanation of the objectives for this area.

Mr Harris suggested that there may be a need to further research the history of this area of the Government Gardens as there may be ramifications arising from this. Mr Spijkerbosch replied that archaeologists have looked into this and were currently seeking Maori Council approval through the Historic Places Trust.

A short discussion followed regarding the use of fencing and seating for this area.

5. IMPACTS OF NEW ZEALAND TRANSPORT AGENCY - ROTORUA EASTERN ARTERIAL

His Worship the Mayor advised that a protest hikoi (march) by members of Ngati Hurunga te Rangi, Ngati Te Roro o Te Rangi, Ngati Uenukukopako and other members of the community had been received by the Te Arawa Standing Committee earlier in the week. A Position Statement had been presented to His Worship the Mayor, to be forwarded to members involved in the decision-making process (Attachment 3).

His Worship the Mayor then introduced Mr Chris Farnsworth (representative from NZTA) who spoke to a PowerPoint presentation giving an overview of the REA project (Attachment 4). He explained that NZTA were proposing to alter the existing alignment on the Sanatorium Reserve and designate a new area on the corner of the Cemetery Reserve, both of which are subject to the Rotorua District Council / Ngati Whakaue Protocol Agreement. He informed members that construction of the REA would be around 2020-2030. NZTA were expecting any decision made will be appealed and will then go to the Environment Court so this process could take approximately three years to reach a definitive decision.

Mr Dave Kent explained that the section of the Cemetery Reserve which NZTA are wanting to utilise is where the 9-hole golf course was, from the traffic lights back down Sala Street (1 parcel of land).

(Mr Mauriora Kingi excused himself from the meeting because of other commitments at 2.00pm.

A discussion took place regarding the direct effects on the Gifted Reserves and the possibility of making Te Ngae Road into a four-lane highway and the implications of this. It was decided that NZTA need to discuss this matter further with the hapu directly affected.



Position Statement of Ngati Hurunga te Rangi, Ngati Te Roro o Te Rangi, Ngati Uenukukopako and the Positive Rotorua Environmental Society



We reject the designated route for the Rotorua Eastern Arterial.

This has been a consistent position of the three affected hapu, for decades. We are united in our opposition to the designated route and its irreversible negative impacts.

There are many grounds for our concerns.

- Cultural the road will desecrate land that is of paramount cultural importance. It will destroy our taonga such as ngawha and puna, which the people of Ngapuna have used and maintained for generations. Important sites are also under threat at Owhatiura and Owhata. The road will cut us off from our wahi tapu and the natural resources which have sustained our hapu through the years. It will hinder movement to our marae and within our communities. Our whanau have lived on the whenua for hundreds of years. It is a taonga that our future generations have a right to live on as tangata whenua.
- Wairua mana atua, mana tangata, mana whenua and mana wairua are vital. The
 decision to proceed with the designated route disrespects the mana and tapu of the land.
 Building the road will imbalance the mana and tapu, compromising the safety of the
 people in our local communities. Tapu is sacred and needs to be nourished; but when
 disrespected, it will have consequences.
- Environmental the road will cut through ecologically significant land highly valued for
 its rare geothermal and wetland features. Tangata whenua are currently enhancing part
 of the land through a Biodiversity Land Management Programme in partnership with the
 Department of Conservation and the Ministry for the Environment. This programme
 aims to improve lake water quality by restoring a natural wetland filtration ecosystem.
- Social papakainga within Ngapuna will be demolished, even though the District Plan states that Ngapuna is a culturally significant village. Rotorua residents who live near the designated route will be detrimentally affected. The community will suffer the negative effects of land loss.
- Safety geothermal reservoirs and natural springs are characteristic of Ngapuna, 'Ngapuna' means the springs. Volatile, geothermal land is not a safe place to build a state highway.

• Economic – the designated route will cost more than the upgrade of Te Ngae Rd. It will also divert traffic away from businesses along Te Ngae Rd and it is questionable that it will deliver any benefits to the Rotorua economy. There will also be the economic impact of the loss of productive potential and capacity of the hapu.

It is clear that these issues were not fully considered when the New Zealand Transport Agency (NZTA) and Rotorua District Council (RDC) chose the designated route for the Rotorua Eastern Arterial. NZTA and RDC should upgrade Te Ngae Rd. It is an existing state highway, with scope to be expanded to four lanes. There is no need to build a new highway, when the current road can simply be improved.

We are frustrated with the lack of engagement by Rotorua District Council. The Council has not properly consulted with tangata whenua. The Council's decision to support the designated route was made following inadequate engagement and consideration of tangata whenua concerns. This has been a poor exercise of democratic processes. We welcome the upcoming audit of the Council's consultation processes with tangata whenua.

We are very disappointed that the New Zealand Transport Agency has not given sufficient weighting to the concerns outlined above. We question the process and substance of the decision to select the designated route as the preferred option for the Rotorua Eastern Arterial.

The development of Rotorua is critical to us. We are not against progress. *He iwi manaaki a Te Arawa*. Our tupuna gave much of our land for the establishment of Rotorua. We have built a worldwide reputation for tourism, hospitality and sharing our culture and natural resources. We support Rotorua's economic development and we believe that NZTA and RDC have chosen the wrong option.

We have suffered already under the Public Works Act, through the loss of the Whakarewarewa Forest and the land for the Rotorua Airport. We have had enough. We will not allow any more land to be taken.

The Rotorua Eastern Arterial designation must be removed, forever.

It is time for all mana to be restored, Te Arawa E TU.






Diagram showing Daily Traffic and Concept of Reserve Capacity At current growth rate REA required between 2020-2025

1. PURPOSE

The purpose of this report is to gain the support from members of the committee to initiate the process for the return of a portion of Centennial Park known as the Rotorua Thermal Holiday Park to Ngati Whakaue ownership.

2. RECOMMENDATIONS

- 1. That the report 'Process for the Transfer of Gifted Reserve (part Centennial Park) back to Ngati Whakaue' be received; and
- 2. That the Committee recommend to Council to commence the public consultation process to enable the land to be returned to Ngati Whakaue.

3. BACKGROUND

The land in question (Lot 1 DPS 61460 refer to attachment 1) was originally part of the Arikikapakapa block. This section of the block was managed by the Crown until 1947 when it was made part of the Rotorua Domain administered by the Rotorua Borough Council. The Arikikapakapa block was gifted by Ngati Whakaue to the people of Rotorua to be used as for recreation and education purposes. This section of Centennial Park forms part of the Gifted Reserves network and is governed by the Gifted Reserves Protocol Committee which has Ngati Whakaue and Rotorua District Council representation.

The motor camp was developed in the early 1950's and was further upgraded after approval of a new development plan in 1954 and the closure of the old municipal camping ground in Glenholme. The motor camp today is bordered by the Waiariki Institute of Technology to the south, Lake Tangatarua to the north, Old Taupo Road to the east and the remainder of Centennial Park to the west. The 12.1625 hectare camp grounds contains a mixture of tent, caravan and motor home sites with cabins, ablution and kitchen facilities, pools, shops, a catered lodge and caretakers cottage.

The Thermal Holiday Park is operated under a lease agreement with Council. The lease was purchased by the Waiariki Institute of Technology in 2012 with the understanding that a portion of the motor camp would be able to be used for student accommodation freeing up for public use when not required. They also have plans to develop a portion of the land as recreational sports fields for their use that can be used by the public

on the same basis. The purchase was made with the full agreement of Ngati Whakaue, both from a Gifted Reserves perspective and from their representation on the board of trustees for the Waiariki Institute of Technology. Ngati Whakaue now claim the use of the reserve has changed from the original intention for what it was gifted for and have requested the return of the land back to them as the original landowners.

The first stage to begin the process for this to occur is to get Council agreement to undertake the public consultation required to enable this transfer to occur.

The following steps may need to be undertaken to enable the hand back of the land to Ngati Whakaue.

- Public consultation to undertake the required processes to enable the transfer of land ownership for the Rotorua Holiday Park back to Ngati Whakaue.
- This may involve the requirement to remove the Reserve designation over this portion of the land before any transfer can be made.
- Amend the Reserves Management Plan as required.
- Minister for the Department of Conservation (DoC) approval to the required processes enabling the land to be transferred to Ngati Whakaue.
- Council to transfer the land either back to the Crown for them to transfer it to Ngati Whakaue or transfer the land directly to Ngati Whakaue.

Some of the above steps, if all required, may be able to be combined through the public consultation phase to shorten the timeframes. Even so, it can take eighteen months to two years for this process to be concluded, assuming that there are no issues that will need to be resolved.

4. **DISCUSSION AND OPTIONS**

Option One: Maintain the status guo. The land remains vested in Council and managed as part of the Gifted Reserve s jointly with Ngati Whakaue.

Option Two: Undertake the required consultation to return the land in its entirety to Ngati Whakaue ownership through the most appropriate mechanism.

Option Three: Subdivide the actual land proposed to be used for motor camp/ accommodation purposes with the remainder intended to be utilised for recreation/ sportsfield purposes continue being retained by Council as Recreation Reserve and managed as a Gifted Reserve under the Gifted Reserves Protocol Committee.

5. ASSESSMENT OF SIGNIFICANCE

The decisions or matters of this report are not considered significant in accordance with the Council's Policy on Significance.

6. COMMUNITY INPUT/ENGAGEMENT AND PUBLICITY

No community consultation has been completed as part of this report. There will however need to be full public consultation depending on the outcome from this report.

7. **CONSIDERATIONS**

7.1 Financial/budget considerations

The financial consideration is that Council will lose the income from the Thermal Motor Camp there by increasing the Parks and Reserves reliance of rates funding for it activities. This has not been considered as part of Councils Long Term Plan but can be considered as part of the Annual Plan process for the 2015 year.

The Thermal Motor Camp rental is currently around \$107,000+GST per year.

7.2 Policy and planning implications

This decision has not been provided for in any Council policy, planning or other document. There will be a requirement to amend the Urban Reserves Management Plan, Councils Long Term Plan and Annual Plan to accommodate this decision.

7.3 **Risks**

The risks of the decision are highlighted below:

- Public consultation may come out against the proposal to return the land to Ngati Whakaue
- Negative perception of Council within the public arena through the perceived loss of reserve land
- No control over the time for DoC or the appropriate central government agency to complete their required processes
- That the Crown does not approve the processes enabling the transfer of ownership
- Council's loss of non-rate funded income

Council has the ability to complete the actions detailed in this report through the provisions of the Reserve Management Act 1977 and the reserve area being vested with Council. Council however does not have the authority to uplift the Recreation Reserve classification as this is only able to be completed by the Minister of Conservation.
