Mayor Chadwick welcomed everyone present, and Mauriora Kingi opened with a karakia.

### 2. APOLOGIES

Resolved

### 3. CONFIRMATION OF PREVIOUS MINUTES

**Resolved** 

That the minutes of the meeting held 10 April 2014 be accepted as true and correct, with the following addition:

• "Point 4 regarding the return of the Rotorua Thermal Holiday Park to include 'other pockets of land requiring clarification, as verbally reported".

### MATTERS ARISING

- Rob Pitkethley to follow up by sending a letter to the Minister of Conservation regarding the return of the Rotorua Thermal Holiday Park land. Mayor Chadwick apologised that the letter had not been sent. The next stage/s to be clarified and communicated to members.
- Mr P Kingi tabled a discussion paper, addressed to MP Todd McClay 14 April 2014 outlining the history of the gifted reserves and the wish of the Pukeroa Oruawhata (PO) trustees to have the titles of the trusts returned to them, while still retaining the original public purpose of those trusts (Attachment 1).
- Garry Page clarified that it was not an option for Council to give land directly back to Pukeroa Oruawhata. Council would have to hand the land back to the Crown, and then the Crown would have to decide what to do with it.
- Peter Faulkner tabled a letter from Stratum Consultants regarding the proposed land exchange between Pukeroa Properties #2 and Rotorua District Council (Attachment 2).

### <u>Resolved</u>

That Rob Pitkethley work with Pukeroa Oruawhata to resolve these outstanding issues, to take a case to the Crown.

### 4. PRESENTATIONS

### 4.1 <u>Smart Futures – Rebecca Burton</u>

Mayor Chadwick and Ms Burton spoke to a Powerpoint presentation titled 'Our District Vision – Rotorua 2030' (Attachment 3).

A discussion was held on the need for collaboration between various stakeholders to meet future infrastructure needs and the growing Maori economy.

The recently-released District Plan was discussed briefly. The Chief Executive made the following comments:

- Factors such as the impact of zoning changes on transport networks had presented challenges.
- The document had been at least 5 years in the making.

Action Point: Peter Faulkner requested an opportunity to meet with Council officers to gain a better understanding of the intent behind some of the decisions made in the District Plan.

### **ATTENDANCE**: Cr Maxwell left the meeting at 3.03pm.

### 5. <u>REPORTS</u>

### 5.1 RECOMMENDATION 1: TE ARAWA SOLDIERS MEMORIAL RESTORATION

Pamela Lovis spoke to a Powerpoint presentation titled 'Te Arawa Soldiers Memorial' (Attachment 4a) and tabled a list of names of Te Arawa men named on the Te Arawa Soldiers Memorial 1927 (Attachment 4b).

There was a discussion about the need to raise 1/3 of the cost before an application could be made to the WW1 Committee. The estimated cost was \$300k for total restoration. Bronze would last significantly longer than wood, but would be more expensive. A potential private/public partnership to undertake this project was discussed. It was generally agreed that a full restoration of the complete original memorial (including Rangitihi) would be preferred. Council would seek funding from trusts and other entities.

Debbie Cossar read out a note from Karl Johnston (Director of NZ Maori Arts & Crafts Institute) regarding the second quote they had provided, for bronze:

"This approach will reinstate the original composition and concept of the Te Arawa Soldiers' Memorial. It will avoid any major repair and maintenance costs. The bronze cast has an undefined life expectancy, conceptually bringing the historic Pou back to life in a new more sustainable material, reinforces the purpose and the concept..."

### **Resolved**

- 1. That the report 'Te Arawa Soldiers Memorial Restoration' be received;
- 2. That the monument be restored to its original full condition.

An application for \$25k to Rotorua Energy Charitable Trust had been submitted. RECT larger funding rounds had closed.

Action Point: WWI Committee to report back on progress.

### 6. <u>GENERAL BUSINESS</u>

Mr Patchell asked for clarification on the lease conditions relating to the Marguerita Street Reserve.

Action Point: A letter would be sent shortly seeking Pukeroa Oruawhata approval to assign the lease.

ATTENDANCE: Mr Patchell left the meeting at 3.35pm.

### 7. <u>REPORTS (CONT.)</u>

### 7.1 <u>RECOMMENDATION 2: CBD GARDENS AND OPEN SPACES IMPROVEMENTS AND ONGOING</u> <u>MANAGEMENT</u>

Rob Pitkethley spoke to a Powerpoint presentation titled 'CBD Gardens and Open Space Improvements' (Attachment 5).

### **Resolved**

- 1. That the report 'CBD Gardens and Open Spaces improvements and Ongoing Management' be received.
- 2. That the Committee acknowledges the measures being put in place to address improving standards in these areas.

### 5.3 RECOMMENDATION 3: POTENTIAL COUNCIL DEVELOPMENTS FOR KUIRAU PARK

Rebecca Cray spoke to a Powerpoint presentation titled 'Kuirau Park – Proposed Development' (Attachment 6). Other comments:

- It is expected that NZTA will provide some funding for the cycleway/boulevard through Kuirau Park.
- Mayor Chadwick spoke about the proposed development of an Onsen Kitchen, which from Beppu had offered to assist with building.
- Grow Rotorua Ltd is working on a business case for a family fun park development through a public/private partnership. Should know more in 6 months.
- The Saturday morning market in Kuirau Park will continue.
- Preliminary geotech work had been done, but more indepth geotech work will need to be done. Preliminary testing had indicated there were ways to engineer around some areas.
- New proposed cycleway will be incorporated.
- Strong cultural history would be acknowledged.

### **Resolved**

- 1. That the report 'Potential Council Developments for Kuirau Park' be received.
- 2. That the Committee support in principle the overall concept of the potential developments for Kuirau Park.

### Action Points:

- Feedback requested from PO trustees on cultural input for depiction panels.
- Updates would be given at subsequent meetings.

### 8. GENERAL BUSINESS

- 8.1 Bella Tait had raised a request for a cadet to be trained through the Education Endowment Trust and Pukeroa Oruawhata. Andy Bell, Henry Weston and Mauriora Kingi would be the appropriate people at Council to contact.
- 8.2 Concerns were expressed about direction of airport/Air New Zealand in the region. Mayor Chadwick advised that she and Oscar Nathan had visited China Airlines but they were waiting for volumes to increase before they looked at flying directly to Rotorua.

Mayor Chadwick had raised the idea of introducing an Auckland – Rotorua – Queenstown link at a recent Upper North Island Mayors' meeting. The Airport company, together with the local representatives of Tourism NZ, have now been asked to develop a business plan to present to the Minister of Tourism NZ, Prime Minister Rt Hon John Key.

8.3 Mr Kingi invited the Mayor to attend the welcome ceremony for NZ Police Commissioner planned for the following Monday at Tamatekapua.

The meeting closed at 4.15pm with a karakia by Mauriora Kingi.

#### Ngati Whakaue Township Reserves

This is a discussion paper on the Ngati Whakaue Township Reserves ("Reserves"), which were set-aside during the establishment of the Rotorua Township in 1880. The purpose of this paper is to provide you with some background information as part of the process to have the Titles of the Reserves returned to Pukeroa Oruawhata Trust on behalf of Ngati Whakaue.

#### Historical Background

At the time the Rotorua Township was being established, Judge Dart Fenton approached Ngati Whakaue and Te Arawa at Ohinemutu to have the Reserves set aside for the benefit of the people of Rotorua. The request by Judge Fenton was some 40 years after the signing of the Treaty of Waitangi ("Treaty"), of which Te Arawa were non-signatories, and following the Maori land wars in the 1860s.

During this period many other iwi suffered the humiliation and indignation of being dispossessed of their tribal lands, the people of Ngati Whakaue were fully involved in the tourism industry opening their ancestral lands to visitors from home and abroad including the world renown Pink and White Terraces.

Ngati Whakaue refused to sell their lands to the Crown but agreed to a 100-year lease agreement. The lessees were English immigrants settling in New Zealand. Judge Dart Fenton then proposed the notion of land being set aside for reserves to cater for such purposes as health, education, leisure, and municipal purposes. Our ancestors were wise and saw an opportunity to further their tourism operations by including those facilities.

In 1880 a formal document was signed between the Crown and Ngati Whakaue and Te Arawa and became known as the "Fenton's Agreement" and often referred to as the founding document of the Township of Rotorua. Following on from the Fenton's Agreement was the Thermal District Act 1880, 1882, and 1883.

#### Post Signing 1880

Sadly, the exciting picture of Ngati Whakaue becoming landlords didn't eventuate, with the proposed leases turning out to be fictitious and no rent monies were ever received. By 1890 it was clear that the lease option was a failure and Ngati Whakaue had no option but to sell some of their lands.

Worse was still to come with the government agent charged with overseeing the sales and purchase agreements failing to have the lands valued at their market value. A review of the land values were carried out by members of Ngati Whakaue who were angry and disappointed at the amount allotted to each land parcel.

The process of settling the lease agreements continued for decades and in 1948 a Parliamentary Select Committee met with members of Ngati Whakaue to offer a full and final settlement for the Pukeroa Oruawhata Block. Ngati Whakaue was somewhat satisfied that the matter had finally reached its conclusion albeit to the detriment of the initial donors of the land and agreed to the price offered. Mistakenly, Ngati Whakaue realised that the offer was for the Pukeroa Oruawhata Block not just the area of the Township.

When word came from the Government that the sale included the Township Reserves, the anguish and confusion continued for over many generations with Ngati Whakaue believing, and rightfully so, that the Reserves still belonged to them. Each successive government has claimed, wrongfully, that the Reserves belonged to Crown.

#### 1988 Rotorua Railway Reserve 13ha

In 1984, the Labour Government lead by David Lange introduced the Rogernomics policies, which resulted in sweeping economic reforms. By 1987, Geoffrey Palmer became Prime Minister with his polices of corporatization of government agencies. In particular the NZ Railways and the lands on which many its tracks and buildings were situated that were surplus to requirements and not being used. The Rotorua railway yards fell into this category and the government proposed that a shopping mall be erected and named after Ngati Whakaue the original owners of the land.

At this time I was the chairman of the Ngati Whakaue Tribal Land Incorporation and I proposed that the committee seek advice on the government's proposal from Richard Charters, a local Barrister and Solicitor and also of Ngati Whakaue descent. Mr Charters was adamant that the Township Reserves still belonged to Ngati Whakaue as they came under the Reserves Act 1977, where they remain today. These Reserves are sacrosanct to Ngati Whakaue and not even the government can alienate them by way of a purchase. When the National Party became Government the Hon Doug Graham was Minister of Justice and the sitting MP for Tarawera was Max Bradford. Mr Bradford arranged a meeting

with the Minister on the 19 January 1991 in Wellington to discuss the Reserves. Richard Charters and Don Stafford accompanied the Ngati Whakaue delegation and Richard put the case about the Reserves in question to the Minister that they were inalienable and that Ngati Whakaue have fervently held the belief that they were always in their possession. To this the Hon Doug Graham agreed and the process was put in place to have the Rotorua Railway Reserve handed back to Ngati Whakaue.

We returned home triumphant!

#### Turning of the Tide

As the chairman of the Ngati Whakaue Tribal Lands Inc., I oversaw the returning of the Railway Reserve to the Pukeroa Oruawhata Trust given that those lands fell within the precinct of the Township.

#### Work in Progress

The first step for the Pukeroa Trustees was to form a holdings company to operate and manage the development of the proposed shopping mall. Then to arrange Protocol and Procedure with the Rotorua District Council (RDC) and government agencies controlling the Reserves.

The relationship with RDC has been working well with regular meetings but there has been no feedback from the government regarding the ownership of the Reserves. Because of this Ngati Whakaue can only assume that the government agencies concerned are of the belief that ownership of the Reserves remains vested with the Crown.

#### Labour Government under Helen Clarke 2002

When Helen Clarke became Prime Minister, she appointed Parekura Horomia as Minister for Maori Affairs. I was pleased with this as I had known Parekura for many y ears so I started talking to him about the return of the Titles and the difficulties Ngati Whakaue was having with the government agencies not wanting to enter into discussion with Pukeroa Oruawhata over the Reserves. Parekura was very sympathetic and said that the Prime Minister must be consulted first. Ngati Whakaue spoke to the PM when on her visit to Ohinemutu for the presentation of the gifts from Queen Elizabeth II to the Haane Manahi whanau by her son Prince Edward.

The request that was put to her was for the return of the Titles to the Reserves back to Ngati Whakaue, but the original 'public purpose' of the Reserves would remain. The PM was agreeable given that the terms of the 1880 Fenton's Agreement would remain as well.

Parekura then determined that the process would begin with the Arts And Crafts Institute and the Whakarewarewa Valley. That process has been going on for some time but an agreement is in sight.

#### **Return of Other Reserve Titles**

The long and drawn out saga of the Reserves which were deemed at that time to be gifts of monumental generosity and goodwill not only to the citizens of Rotorua but to the nation as a whole and visitors from abroad.

In summary, Todd, this case history that began in 1880 and set out for your information is vastly different to the Waitangi Tribunal claims that are currently going through the settlement process with iwi around the country.

Because a settlement process was not addressed by Parekura Horomia to deal with the other Reserves in question, Ngati Whakaue is unable to get a final agreement on their status. These Reserves lie under a myriad of government and local body institutions of around 12 organisations.

This paper provides an abbreviated timeline of history of the Ngati Whakaue Township Reserves for you to put to the Prime Minister, John Key. It is important for you to know that our preliminary approaches to certain Heads of Staff have been met with total resistance under the premise that the Reserves are inalienable.

This is why a coordinated approach should be carried out to ensure the Reserves are handed back to Ngati Whakaue and not merged and assimilated in to the national hierarchy along with the many other Reserve lands.

#### Closing

It is my wish that you will read this paper while I am there with you in order to answer any questions that you may have before you think carefully about its contents. There after I would hope that you will find time to meet with Malcolm Short and the other Trustees as well as our administrators.

#### Appendices

#### Appendix 1.

Set out below are two examples of the attitude of the Crown still treating the Ngati Whakaue Reserves as their own:

- 1. When the Minister of Justice agreed to the return of the Railway Reserve to Ngati Whakaue he learnt that it had been sold to another government agency. He then had to repeal the sale before handing the land back to Ngati Whakaue.
- 2. When the Rotorua Aerodrome consisting around 5ha became too small, it was shifted to its present site at Te Ngae and the land that was left vacant was named after Judge Fenton and former Mayor Murray Linton instead of being handed back to Ngati Whakaue.

It is interesting to note that when the Railway Reserve was handed back, the RDC set up Protocols and Procedures to with the Pukeroa Oruawhata Trustees, which is going well.



#### Te Arawa Soldiers Memorial

#### Background...

- Erected by Te Arawa in Government Gardens to commemorate Te Arawa men who fought and died in WWI
- 35 Te Arawa men named on the memorial, four more are listed in the 1927 Souvenir Programme
- Memorial unveiled 28 February 1927 by HRH The Duke of York, later King George VI, during a Royal Visit to NZ
- Memorial portrays key events in the history of Te Arawa and interactions of Te Arawa with pakeha during World War One

#### Te Arawa Soldiers Memorial

#### Key features...

- Gothic style, made from Sydney gritstone (a hard sandstone) and Belgian marble
- Memorial has eight sides symbolising "Nga Pumanawa e Waru o Te Arawa"- the eight beating hearts of Te Arawa
- Eight carved totara figures (tupuna pou) originally around the memorial representing the eight children of Te Arawa ancestor Rangithi
- Carving of the Arawa waka at the base, originally a stone statue of Te Arawa ancestor Rangithi stood on the stone block

Te Arawa Soldiers

 A Krupps field gun, thought to have been captured by the Maori Pioneer Battalion at Le Quesnoy, northern France was located at the front of the memorial

 The gun was enclosed by four identical carved posts and a chained fence

#### Te Arawa Soldiers Memorial

#### History

- Statue of Rangitihi vandalised 1936, remaining portions in RM collection
- Carvings vandalised and some stolen 1990/1991
- Remaining carvings placed in care of RM by Arawa Trust Board, Dec 1992
- Krupps gun removed and placed in storage
- Gun restored 1998, replaced in new position
  Twelve original carvings replaced by twelve identical concrete moulded figures (c.1998?)
- Two tupuna pou and four identical wheku form tekoteko currently in care of RM

### Te Arawa Soldiers Memorial

#### History

- Report by David Pound for RDC (1998?)
- Inspection and maintenance report Feb 2008 for Rotorua Museum by Detlef Klein, Manawatu Museum Services
- Overall condition of memorial in 2008 was "generally be considered to be good", all stonework in good condition
  - Cleaning and maintenance programme
  - recommended in 2008
  - Conservation of King George V figure required, and decisions on restoration of original features

### Te Arawa Soldiers Memorial

#### Conservation and restoration...

WW100 Committee investigating costs and options for memorial conservation, restoration and interpretation as a key Rotorua WW1 commemoration project

Estimated cost more than \$100,000

Proposed funding application to WW1 Lotteries for around two-thirds of the cost, closing Feb 2015

Possible project completion in 2018

RDC has engaged Manawatu Museum Services to develop a Conservation Plan in liaison with RDC

#### Feedback?

Overall proposal to conserve and restore the memorial and apply for Lotteries funding

Possible options: - conservation or restoration of the Rangitihi statue - conservation or replacement of original eight tupuna carvings; options for replacement (material, size, cost)
 - conservation or replacement of four wheku tekoteko; options for replacement (material, size, cost)

Community engagement: - research and tell the stories of the 39 Te Arawa men who fought and died in WW1 - interpretation and publication options




